



Instructions for Giving Stock and Mutual Funds

The Letter of Authorization (LOA) on the following page is for your convenience to contribute publicly traded securities such as stock and mutual funds and cash through your brokerage account. Please contact your financial institution to request their required procedures and forms and to provide them with the delivery instructions found below.

All contributions to the **Alternatives Pregnancy Center Single Charity Fund** are irrevocable and are in most cases eligible for a tax deduction. Individual circumstances vary. Please consult your tax advisor regarding your specific situations. Gifts from other tax exempt organizations are not deductible.

Please note that if you are sending physical stock certificates or stock held at a transfer agent, do not use the attached Letter of Authorization. Instead, please contact Alternatives Pregnancy Center.

If we may serve you in any way, please contact us using one of the options provided at the bottom of this page.

Step 1: Initiate the Transfer with Your Broker

To transfer stocks or mutual funds that are being held electronically, please use the Letter of Authorization on the following page and instructions below. Include the giver's name and Alternatives Pregnancy Center Single Charity Fund #1513752 on all deliveries.

Step 2: Notify Alternatives and NCF About Your Transfer

Step 3: Confirm Your Transfer

Transfers must be initiated by your financial advisor or broker. Please confirm with your broker or advisor that your gift has been transferred from your account to NCF's account. Once received, the gift will be liquidated, settled, and completely posted to Alternatives Pregnancy Center Single Charity Fund. For tax deduction purposes, you will receive a gift acknowledgement from National Christian Foundation.
