



#### Teens. Women and Men Served

Alternatives and A Promising Future served over 7,281 teens, women and men in 2014. Staff and volunteers initiated and received 9,223 client contacts. Teens and women seeking information and counseling made over 2,209 visits to our offices.

#### **Babies Born**

In the calendar year of 2014, we have recorded the names of 362 babies born to our clients, who gave us written permission to stay connected with them. We will learn of many other babies born as 2015 progresses and clients contact us.

#### **Unintended Pregnancy Support**

Our clients received 815 pregnancy tests with options counseling; of those, 474 tested positive.

#### **Ultrasound Services**

We provided 346 women with 400 ultrasounds.

#### STD Testing & Treatment

63 women received 674 tests for sexually transmitted diseases, and 53 treatments were provided. Through life-affirming counsel, Alternatives helped these women reevaluate their sexual choices.

#### Mobile Testing Clinic

Our Mobile Testing Clinic enabled Alternatives to reach women in underserved communities at six strategic locations and created meaningful partnerships with other like-minded service providers.

#### **Direct Client Support**

Over 1,032 gifts of financial and/or material assistance were provided, including: 314 Bottles of Prenatal Vitamins 683 Community and Medical Resource Guides 270 Gift Lavettes (Baby Shower in a Bag) Other gifts of material services included pregnancy books, A Season to Heal books, and grocery gift cards.

#### **24-Hour Helpline**

Alternatives received over 2,575 client-related calls on our Helpline.

#### **Request An Appointment Online**

Request An Appointment became available on our website in July and resulted in 30 new clients served.

#### **Reconciling Abortion Loss**

An average of 282 individuals receive our help annually with emotional pain and loss due to a past abortion through our individual counseling and support groups.

#### **Relationship Education**

A Promising Future provided over 3,518 education hours in healthy relationship and success development classes, school assemblies, parent education, workshops, conference seminars and community events. 3,231 youth, families and community partners were served throughout Denver, statewide and even nationally. Of these, 691 participants received psycho-social skill development through our in-depth curriculum, The Diamond Standard.

In addition, A Promising Future completed a comprehensive revision of The Diamond Standard including an overhaul of session content, activities, graphics, and a pilot class prior to finalization. This revision enabled our program to train 21 new educators in our newly enhanced curriculum and to market the curriculum as a self-taught resource to partners nationwide. Nine new partners purchased the curriculum including other pregnancy centers nationally.

#### Volunteer Involvement

922 individuals provided over 16,118 hours of volunteer service including counseling, medical and office support and full coverage on our 24-Hour Helpline. Their time and talents equipped Alternatives to serve our clients in every aspect of our ministry.
