**Momma Mentor**

**Supervisor:** Momma Mentor Coordinator

**Position Summary:**

The Volunteer Momma Mentor empowers first-time mothers and mothers of other children by providing a non-judgmental space to process and learn about motherhood basics and characteristics. The Volunteer Momma Mentor will enter a long-term one-on-one relationship with the client and will help educate, enable and encourage him to become an involved and effective mother.

**Time Commitment:**

- Upon completion of training, at least two years of serving two to four shifts per month (each shift is two hours long).
- Attend two (2) Alternatives Continuing Education Events per year.
- Inform the Momma Mentor Coordinator as soon as possible if unable to make assigned mentee session.
- Attend quarterly Momma Mentor “get-togethers”.

**Application Requirements**

- Attend a Volunteer Orientation.
- Attend a Foundations Course.
- Apply by the given deadline (provided by the Volunteer Development Manager).
- Be formally interviewed by Supervisor and Department Head or Volunteer Development Manager (scheduled by Supervisor and Volunteer Development Manager.)

**Training Requirements**

- Google Classroom Prep Work: 3 hours
- The Alternatives Approach Training: 15 hours
- On the Job Training: 6-8 hours
- **Total Hours of Training: 24-26 Hours**

**Refreshment of Skills**

- Reviewing Alternatives’ approved motherhood resources, literature, practicing occasional role-plays
- Attend two (2) of the three (3) Continuing Education Events scheduled by the Volunteer Development Manager.
- Participate in an annual skills observation and evaluation.
- On-going supervision with the Momma Mentor Coordinator.

**Essential Duties & Responsibilities:**

- Follow Alternatives’ Policies and Procedures.
- Meet twice a month with clients who are first-time mothers or mothers-to-be.
- Partner with other Momma Mentors, Client Advocates and Client Services Staff to serve the client/family unit.
- Maintain accurate client records.
- Maintain confidentiality in all client situations and circumstances.
- Review assigned client files at each session and follow through on appropriate case management tasks.

- Debrief with the Momma Mentor Program Coordinator regarding client sessions and follow-up case work.
- Demonstrate knowledge and proficiency in sharing and leading clients through Alternatives' approved motherhood resources.
- Commit to attending Alternatives' Continuing Education Events to remain equipped to meet with clients.
- Dress casually and modestly.

### **Qualifications**

- A mother.
- A growing follower of Jesus Christ.
- A willingness to learn and an attitude of service and acceptance.
- Respect of the client and her family.
- The ability to listen first, speak second and empathize with others.
- Dependability to follow through on commitments.
- Maintain flexibility and manage personal expectations within the varied elements of crisis work and coaching.

### **General Requirements**

- Acknowledgement and agreement of Alternatives' Statement of Faith, Principles and Mission Statement.
- Complete the volunteer application and three reference forms.
- A completed background check performed by Alternatives.
- Complete the required volunteer training, The Alternatives Approach.
- Commitment to enlisting at least one (1) individual to support you in prayer.
